



SOUTHEAST CONSERVATION DISTRICT EMPLOYEES' ASSOCIATION PROFESSIONAL TRAINING SCHOLARSHIP

OBJECTIVE

The Southeast Conservation District Employees Association **Professional Training Scholarship** provides financial assistance to members of the Association who are currently employed but unable to attend the Annual SECDEA Conference due to budget constraints. Assistance will be provided for registration and travel, with some restrictions.

ELIGIBILITY

Applicant must: (a) be a member in good standing with their respective states' district employee association (b) have demonstrated integrity, ability, and competence in his or her work (c) have completed at least one year of employment with a soil and water conservation district. (d) guarantee attendance of the entire conference starting with opening ceremonies and ending with the banquet (e) have local Board approval to attend the conference prior to submitting application and (f) show reasonable financial need

AMOUNT

Scholarship monies will cover the cost of hotel accommodations, registration, or other incurred expenses at the discretion of the scholarship committee. (Expenses up to, but not exceeding \$500) Receipts are required and must be submitted to Hope Daley within 30 days of conclusion of conference. Applications will be reviewed, and the Scholarship Committee will make the selection.

APPLICATIONS

Applications for the scholarship must reach the SECDEA Scholarship Committee Chairman, Hope Daley by **Friday, August 23, 2024.**

CANCELLATION

If for any reason the recipient of the scholarship needs to cancel, please do so in a timely manner and be sure to let Hope Daley, Scholarship Chairman know. You are responsible for contacting the hotel to cancel room reservation. If the recipient has a last-minute cancellation, the recipient will be responsible for any incurred expenses that cannot be cancelled or refunded. The SECDEA will bill recipient/District.
